The Port of Brookings Harbor District & Curry County met in special session on the above date at 10:00am. Open session at the Port Conference Room, 16350 Lower Harbor Road Suite 202, Harbor OR, 97415, teleconference and webinar.

A grant will be able to bring the culvert to City and County standards. Roadmaster stated that private storm drain must be maintained and repaired by the responsible party. Which a portion of this culvert runs through Port property, so it's the Port's, unless there is an easement dedicating it to the County and that the County Commissioners accepted that easement. Heap explained to the County that what falls out at the end of that pipe should not be the responsibility of the Port. The Board's continued to discuss the culvert and grant options. There was also a discussion about the American Plan Rescue Fund and the wastewater treatment plant.


