### 1. Call to Order, Pledge of Allegiance and Roll Call:

Vice Pres. Barbas made a motion approving the removal of Andy Martin and Roger Thompson as authorized signers to all Umpqua Bank Accounts including: Public Checking Account #973273634, Public Checking Account #4869398018, Money Market Account #0972079529 and Money Market Account #0972678627. Second by Pres. Christian. Voting yes: unanimous.

Vice Pres. Barbas made a motion approving the removal of Andy Martin and Roger Thompson from all Oregon State Treasury Local Government Investment Pool Accounts including: General Fund Account #6017, Reserve Fund Account #6018, Capital Projects Fund Account #6019, Debt Service Fund Account #6020, USDA Revenue Bond Fund #6021. Second by Pres. Christian. Voting yes: unanimous.
