### Port Office

- 1. Port employs nine (9) full-time employees and 1 part-time employee.
- 2. Currently, the Port is operating businesses RV Park, Boat Yard, Fuel Dock, Marina, Gear Storage and Retail seven days a week.
- 3. Approx. end of the week QuickBooks balances for the Port:
  - \$ 20,089 General Fund (Transferred \$5,000 to Debt Services for IFA payment)
  - \$ 4,381 Fuel Dock Account
  - \$ 2,500 Capital Projects Fund (\$2,500 must be in the account to avoid monthly charges)
  - \$ 36,500 Debt Service Fund (IFA, Travel Lift Lease, Etc.) (1st Quarter due March 31 \$62,500)
  - \$ 10,197 Revenue Bond Fund (USDA Loan \$130,200 payment due November 5<sup>th</sup>)
  - \$ 1,219 Cash on Hand/Petty Cash (cash for RV Park, fuel dock and office)
  - \$ 74.886 Total Cash as of 4/08/17
  - \$127,724 Accounts Receivable as of 4/08/17

- 7. OSMB inspected the sani-sailors this week. Bi-annual inspection of the systems to make sure equipment is functioning.
- 8. At some point this week, trailer with dredge pipe was dropped off by Kenny's Boat Shop. Dredge pipe apparently came from Port of Coos Bay, Port of Alsea dredging project. Port of Brookings Harbor was not notified it was coming.
- 9. Dave Hoover Construction could not make this week construction meeting. Dave was picking up materials for the camel bumpers. The construction is being delayed because of the camel bumpers getting added to the corrugated sleeve. There are no foam vendors available to place the foam on the sleeves. Dave is working on a solution to get equipment and materials to do it himself.

### RV Park

1. Installed new and improved Wi-Fi system. Wi-Fi system will extend to Basin 2 once the last rely is installed at the Kite Field restroom.

- 2. Repaired picnic bench at Site 85.
- 3. Tent was setup in the campsites and he refused to pay the rate, he thought it was only \$5. He was told leave and he did.
- 4. Opened some rocks for access to the west end of the beach.
- 5. Cable TV enclosure was knocked over at Site #93. Dug up the enclosure and reset it.
- 6. Planter boxes at the RV Office were removed because they're falling apart.
- 7. Repaired gate at Site 31.
- 8. Repaired fence throughout the park from the damaging winds.
- 9. Cable TV was reported out Saturday. Brent came in and worked on it and got half the channels back. Will need tech to come in Monday to adjust the dish. The wind the other day moved the dish and caused the outage. Some customers were complaining.

### Docks - Sport / Commercial Sport / Commercial

- 1. Installed utility hangers from Basin 1 Sport E docks on Basin 2 Dock P and hung the power cable we replaced about a year ago. New hangers would have cost several thousand dollars.
- 2. Vessel at Sport A-10 came loose. The bow line broke. Boat was retied.
- 3. Received report of light pole cover was falling off at Basin 2 at the electric building for docks I & J. Barricaded off the area below the light pole. The cover is a plastic dome. Coos-Curry Electric was contacted to determine if this pole belongs to them or Port.
- 4. Dock corner piece blew off at Sport C-25 and was reattached.
- 5. Wind broken lines and cleats on vessels throughout Sport Basin 1. Retied vessels and added rope to Sport B-25 and 27.
- 6. Wind broke two electrical pedestals at Sport Basin 1 A-9 and Basin 2 H-14. Pedestals were reattached and duct taped for now. Checking inventory to see if we have pedestals to replace the broken ones.
- 7. Reset barricades along Basin 2 Kite Field sidewalk.
- 8. Slopes along Basin 2 Kite Field side continue to slide.
- 9. Completed boat inventory and checked vessels for any more issues.

### **Boat Yard**

- 1. Landscaping was done around the boat yard.
- 2. Yard gate was damaged by the wind and was repaired.

### Maintenance Yard / Shop

1. Serviced port equipment.

### **Boat Launch Parking Lot**

1. Fish Station cleaned by Port staff as needed.

### Commercial Fishing Docks / Gear Storage

1. Completed one crane job for the commercial fishing fleet.

### Retail / Boardwalk

- 1. Trash removal by Port staff as needed throughout the Port.
- 2. Restroom cleaning done by Port staff every day.
- 3. Sewer Pump #1 shutdown. Down to one sewer pump. If both pumps go down, retail shops will be closed until repairs are made. Continue working on quotes for rebuilding the sewer tank system.
- 4. Boardwalk Mail continues to have a musty smell. Staff checked the attic for any mold and none was found.

5. More roof flashing came off the retail buildings from the wind.

### Fuel Dock

- 1. 1,083 gallons of diesel and 0 gallons of gas was pumped this week.
- 2. Approx. inventory in the aboveground tanks for diesel is 7,012 and gas 2,226.
- 3. Carson Oil delivered 3,005 gallons of diesel. It was left over from Coast Guard delivery.

### Security

1. South Coast Knight Security is patrolling the Port properties. Reports attached for review.

### FEMA / OEM PW's

- 1. Continue removing hardware off Sport E docks and storing docks in the boat yard.
- Called Jack Akin/EMC regarding the FEMA piling project and the current in-water work permit. Tyler
  Krug/USARMY CENWP sent an email this morning to withdraw the current request for Nationwide Permit
  until things are straightened out with FEMA and HMGP. Jack said it won't be a problem to get the permits
  going again and we should withdraw it for now. I responded to Tyler and Jack did as well.
- 3. Asked Jack to check with HMGP for the status and provide a schedule for the piling project. He will have an update for me by next Monday.
- 4. Emailed Julie/OEM to get an update on FEMA status for the piling and our current emergency declaration. I also told her we are spending time on the 2016 FEMA Piling damage now because conditions have worsened and made it unsafe. She said the project still needs to go through the final stages of approval. The current declaration might have answer by end of next week.

### **Miscellaneous**

1. Held a safety/operation meeting with staff. Jenny/OSMB was here to inspect the sani-sailors so she talked about clean harbors. Reminded everyone we are closing and locking the gear storage gates at the end of the day and opening them if they aren't already in the morning. All the commercial fishing companies have keys to the gates. Reminded field staff the restrooms must be clean every day and checked for supplies twice a day


