- 9. Prepared documents for trip to Salem (attached)
- 10. Thursday May 18, Danielle and I carpooled to Salem to meet with legislators on Joint Committee On Ways and Means for support on SB 646 Infrastructure Repair ask for \$3 million. We met with 11 Senators and Representatives which all pledged their support if it comes to a vote. All the other members we did not met in person, we dropped off our filer with their office associates.
 - While discussing SB 646 with various Senators and Representatives; we found out SB 5530 Lottery Bund Appropriations is scheduled for a hearing tomorrow at 1pm. Even though SB 646 is not listed within SB 5530, we need to submit a written testimony and someone representing the Port in person. All this information was not available or known to everyone we met. Rep Dave Brook Smith and staff was very helpful with submitting our written testimony this evening and getting all this figured out. Also, David plans on speaking on the behalf of the Port tomorrow. If we had known of this hearing happening tomorrow, we would have planned to be there.
- 11. While in Salem, we stopped by IFA Business Oregon office and met with Mark Freeman, Dave Harlan and Chris Cummings to provide an update on Port business.
- 12. Inserting notice in June Statements mailings of rate changes effective July 1, 2017.
- 13. Reviewed resubmittal documents from the supplier on retail sewer tank system upgrade. Emailed resubmittal package to Kelly/Harbor Sanitary for their review and approval.
- 14. Received Corps of Engineers permit approval for emergency dredging at the travel lift ramp and storm drain. Work window must be completed before July 15th. Engineering is being performed on the wood deck to see if it can hold the weight of the excavator. If it can't, we have a secondary plan in place to get the dredging accomplished.

<u>RV Park</u>

- 1. Harbor Sanitary inspecting and cleaning main sewer lines inside the RV Park this week. Provided them access to the manholes.
- 2. Replaced GFCI breaker at Site 86.

<u>Docks - Sport / Commercial Sport / Commercial</u>

- 1. Port received a call regarding a vessel at the end of Basin 1 C-Dock. While checking out the vessel as to why it was moored, the vessel in C-6 was listing badly and needed water pumped out. Vessel at the end of C-Dock had steering failure and needed to tie-up there for the night.
- 2. Another vessel tied up the Basin 1 D-Dock that should not be there. They were instructed to move to transient dock.
- 3. Boat inventory was completed this week.
- 4. Repaired broken waterlines at Basin 1 G-10, G-26 and F-1.
- 5. Removed two broken water heaters from commercial basin restroom/showers and installed one new water heater. One water heater is all it needs. Been operating with one for a year now.
- 6. Replaced broken electrical meter Basin 2 N-10 (Gowman).
- 7. Removed propane tank left on N-O dock in Basin 2.
- 8. Filled in potholes in commercial basin parking lot.
- 9. Main waterline broke to E Dock in Basin 1. Line was capped. E Dock is gone.

Senate Bill 646 Joint Committee On Ways and Means May 18, 2017

TO: Co-Chairs and Esteemed Committee Members

Port of Brookings Harbor is seeking financial assistance for the purpose of repairing and improving docks, marine infrastructure and facilities owned by the port.

You may be aware that the Port of Brookings Harbor has been working with entrepreneur Mike Manning of BC Fisheries in an effort to revitalize the local commercial fishing industry. Thanks to the support of Oregon State Legislators HB 5030, we were able to complete the first phase of a \$10 million state of the art seafood processing facility here at the Port of Brookings Harbor.

Completion of this first phase retained six (6) family wage jobs, created thirty (30) new family wage jobs, increased the economic development of the community, the commercial fishing industry and the South Coast Oregon Regional economy.

SB 646 would be the second phase in upgrading and reconstructing the commercial receiving docks, improving and repairing Port infrastructure, as well as providing Port resiliency to natural disasters.



The second phase would repair 100-foot section of broken, unusable commercial receiving dock for Pacific Seafood. The reconstruction of this broken section of receiving dock would increase productivity and therefore creating twenty (20) to twentyfive (25) family wage jobs along with continued support to the local economy. Other Port infrastructure repairs would include dredging vital areas of the harbor, basin slope failures, dilapidated sewer facilities, etc.
