They provided some history of the vessel and agreements they had with the port. They would like to see the vessel displayed here at the port or somewhere else if this port can't support it.
- Bruce/Pirate Festival regarding the event and his plans for setup and security.
- Cheryl Clines, moorage holder, regarding her account and vessel at the port.
- Gregg Gardiner/President with 101 Things To Do in Oregon magazine.
- 5. Emailed Tyler/Corps, Robert Lobdell/ODSL and Jack/EMC that we finished the emergency dredging at the travel lift ramp and thanked them for their support and help getting this done.
- 6. Made some updates and changes to 101 Things To Do in Oregon magazine ad and continued the ad for another year.
- 7. Jennifer/OSMB called to explain the hardware and software they mailed to the Port for the Sani-Sailors. The old equipment is not working properly for online monitoring. She gave me information once the new equipment is installed to contact for getting it working from Marine Sync.
- 8. Removed "no firework" signs throughout the port.
- 9. Completed MAP grant FY2016-17 reporting paperwork and emailed to OSMB.
- 10. Attached are reports of Accounts Payable and Receivable from 2009 to current.

### **RV Park**

- 1. Frontier repaired the internet at the RV Park Office.
- 2. Removed jammed quarters from shower coin dispensers #1, #4 and #5.
- 3. Landscaped entrance and tent sites.

#### Docks - Basin 1 & 2 and Transient

- 1. Boat inventory completed for both basins.
- 2. Watering Kite Field grass for the upcoming event taking place on the field.
- 3. Port staff was told there used to be aerators in Basin 2 near the boat yard warehouse. Staff investigated for any signs of aerator equipment and none were found. If aerators were in Basin 2, they are not there anymore.
- 4. Finished installing new toilets, faucets, lights and hand dryers at Kite Field restroom. Repaired waterline to the restrooms and placed the irrigation spigots on the dock waterline. Restrooms were open to public use Thursday afternoon. Doors were installed to lock the restrooms from 10pm to 4am daily.
- 5. Repaired broken copper waterline in the Kite Field restroom.
- Kite Festival began setting up their event at the Kite Field. Event takes place on Saturday and Sunday, moorage holder parking only signs were placed in the parking lot.

#### **Boat Yard**

- 1. Mike Smith continued demolishing vessels Polaris and Skip. Debris being hauled off Port property. Work getting done at no cost to the port.
- 2. Three vessels were placed back in the water this week.
- 3. Waterline next to the travel lift pressure washer sprung a leak underground and was bubbling to the surface. Dug up the line and found it rusted away. Water was turned off and isolated for now.

#### **Boat Launch Parking Lot**

- 1. Fish Station cleaned by Port staff as needed.
- 2. Received more complaints of out of the area fish being brought in and fileted here. Port staff talked to the fishermen bring fish here and they plan to bring a proposed solution to the port.
- 3. Reviewed landscaping plan for the parking lot with staff. Ordered rental equipment for next to begin landscape work.
- 4. Boat launch machine was vandalized from someone trying to break into it. Coating around the door and weather seal was damaged.

### Commercial Fishing Docks / Gear Storage

1. None

### <u>Retail / Boardwalk</u>

- 1. Trash removal by Port staff as needed throughout the Port.
- 2. Restroom cleaning and restocking by Port staff every day.
- Gathered up all the barrel trash cans that were purchased from Port of Bandon. Barrels supposed to have screws in every slat to help keep it together. Port of Bandon picked up the barrels and will be repairing them at no charge.
- 4. Someone left a wheelchair on the Boardwalk. Wheelchair was removed and delivered to Sheriff Substation.
- 5. Pacific Excavation completed the sewer tank upgrade at retail center and the restrooms were reopened Wednesday morning. Water usage had to be controlled from all the tenants that use the sewer system during the outage. Staff made sure the tenants were handled the best we could during the outage.
- 6. Zola's building a storage unit behind the restaurant where the old boat storage unit used to be. No one from Zola's informed the Port of this type of work. I was told this plan was in the package presented to the Board months ago. The plan didn't clearly indicate a wood frame structure.
- 7. Filled potholes in parking lot between Zola's and Sporthaven.
- 8. Replaced leaking spigots behind the retail restroom and next to retail center building #2.
- 9. Saturday Market was held at the Boardwalk hosted by Chetco Brewing, Half the Boardwalk was used.

#### Fuel Dock

- 1. 1,619 gallons of diesel and 434 gallons of gas was pumped this week.
- 2. Approximate inventory in the aboveground tanks for diesel 3,538 and non-ethanol 1,640.
- 3. Received compliant from one vessel of possible water in our fuel. We checked our tanks for water and none was detected. Department of Ag was here on 6-2-17, they also checked the tanks and no water was detected.
- 4. Carson Oil delivered 2,292 gallons of diesel this week. Called Carson Oil to asked them about water in their fuel. They check their tanks twice a week and they haven't had any issues with their tanks.

#### Security

1. South Coast Knight Security is patrolling the Port properties. Reports attached for review.

### FEMA / OEM PW's

1. Received revised JPA for Basin 1 Piling Replacement project from Jack Akin/ EMC. Staff took the JPA to County Planning for their signature, so there would be no delay getting the document submitted to Corps and DSL. Revised JPA was emailed to Corps and hard copy mail to DSL.

- 1. Safety meeting with staff was held. Topic was on procedures and reporting of accidents and injuries.
- 2. Dave Hoover resumed working on the new dock at BC Fisheries installing the second crane.
