RESOLUTION NO. 2023-02

A RESOLUTION OF THE BOARD OF PORT COMMISSIONERS FOR THE PORT OF BROOKINGS HARBOR ADOPTING LANDING FEE RATES

WHEREAS, the Port of Brookings Harbor is a port district, organized and operated under the provisions of ORS Chapter 777, and has the authority to adjust fees and rates by resolution; and

WHEREAS, ORS 294.160 requires the governing body of a unit of local government to provide an opportunity for interested persons to comment on the enactment of any ordinance or resolution prescribing a new fee or a fee increase; and

WHEREAS, the Port desires to adjust its landing fee rates, effective on July 1, 2023.

NOW, THEREFORE, be it resolved by the Board of Commissioners of the Port of Brookings Harbor, Curry County, Oregon as follows:

- 1. The Port of Brookings Harbor Board of Commissioners ("Commissioners") approves charging landing fee rates to all Port of Brookings Harbor leased receiving dock hoists, in accordance with the rate schedule titled "Rates FY 2023-24, Section 9, Public Dock Hoist / Landing Fees," which is incorporated herein by reference as Exhibit A
- 2. The approve the billing of all landing fee rates on a quarterly basis.
- 3. All fees collected from landing fees will be placed into the Port of Brookings Harbor Reserve Fund under a line item titled "Landing Fees." Fees will be allocated to repair, maintenance and/or upgrades needed to the receiving docks.
- 4. All previous landing rates and fees adopted by resolution that conflict with these resolutions are hereby repealed.
